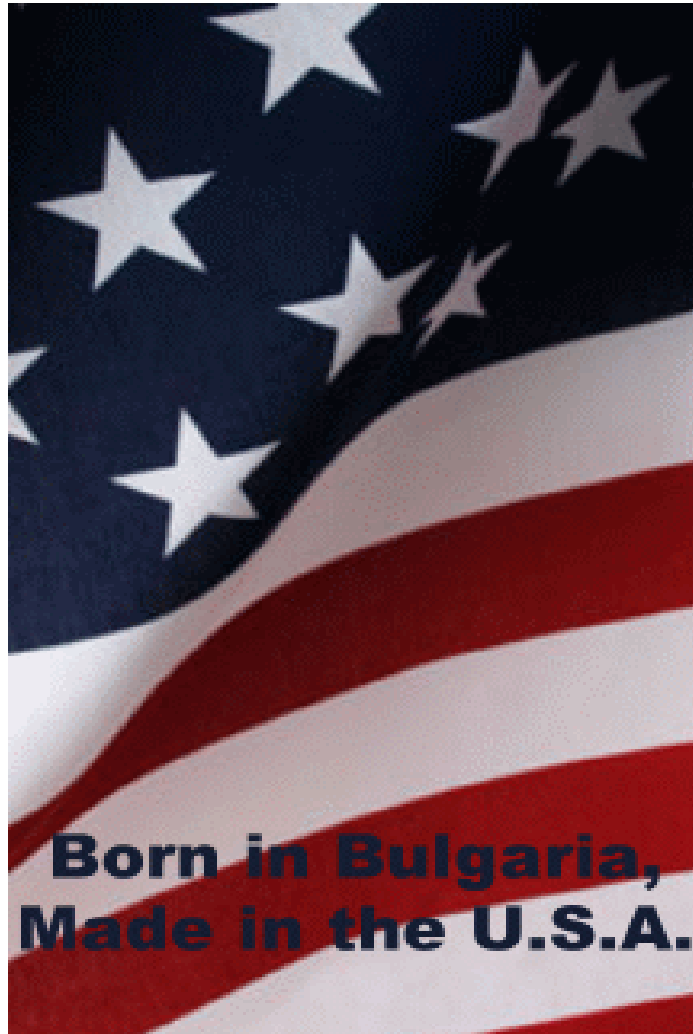

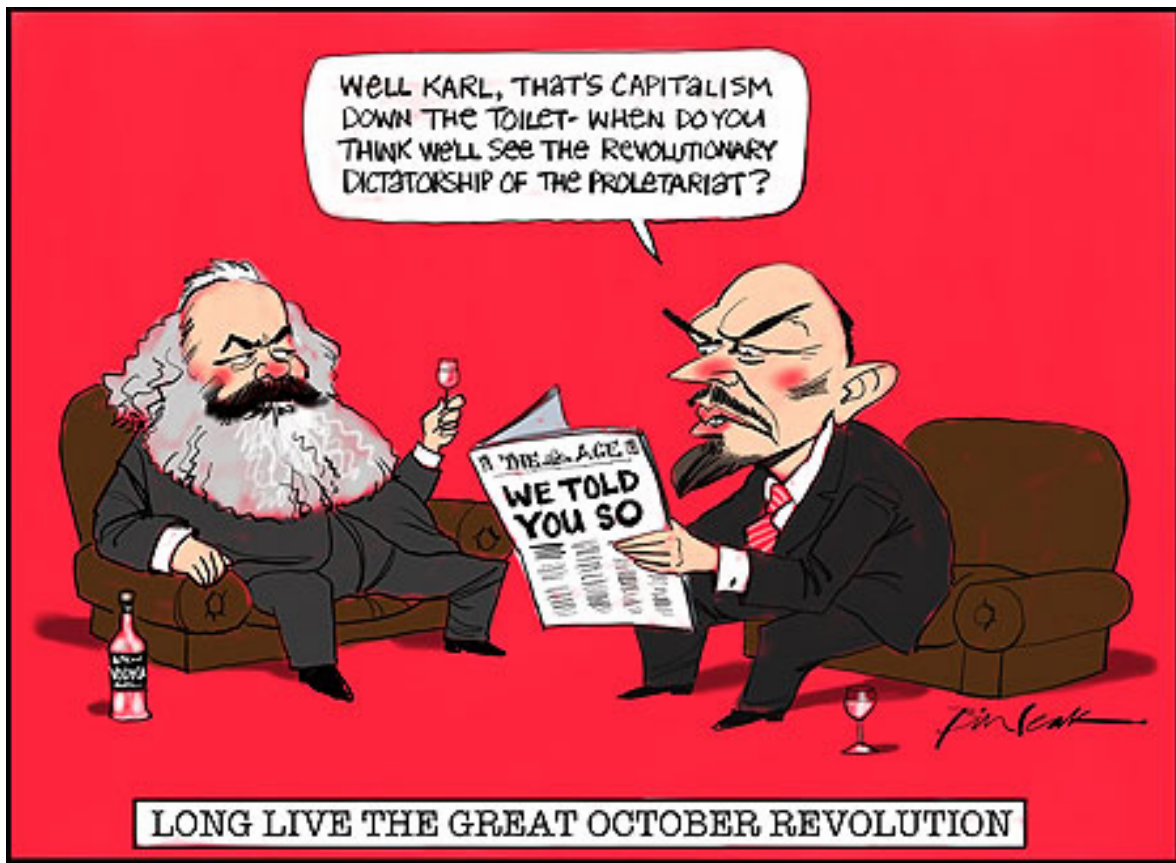
Maverick

Tax Treaty & Protocols

Washington, DC – On December 16, 2008, the U.S. Department of the Treasury announced that a new tax treaty (and accompanying protocols) with Bulgaria entered into force December 15, 2008. This agreement is designed to avoid the possibility of double taxation and prevent fiscal evasion with respect to taxes on income for U.S. and Bulgarian firms operating in each others' countries and thus, spur international trade and investment between our countries.

The treaty and first protocol with Bulgaria was signed in Washington on February 23, 2007, and the second protocol with Bulgaria was signed in Sofia on February 26, 2008. The U.S. Senate approved the new treaty and protocols on September 23, 2008.
